For the purposes of the provisions of the General Data Protection Regulations cited above, the personal data that you send us through the web forms, will receive the data treatment of "Users of the web and subscribers". #### Principles that we will apply to your personal information

- Principle of integrity and confidentiality: your data will be treated in such a way that an
  adequate security of personal data is guaranteed, and confidentiality is guaranteed. We
  take all necessary precautions to prevent unauthorized access or improper use of the data
  of our users by third parties.

#### What are your rights when you provide us with your information?

Interested persons have the right to:

#### For what purpose do we treat your personal data?

Your personal data will only be used for the following purposes:
